The Renter agrees to the following terms and conditions:

1. The rental equipment remains the property of Medela, Inc., Hollister, Inc., or the Rental Station. Renter has no right to such equipment except as stated in this Agreement.
2. Renter agrees to handle the equipment with the utmost care and to pay current list price for all damaged and/or missing parts.
3. Renter may purchase an accessory kit that corresponds to the equipment. The kit becomes the personal property of the Renter.
4. Renter agrees to pay all rental fees in accordance with the fee structure designated by the Rental Station. All fees are due in advance.
5. Renter agrees to return the equipment in the same condition as received. Renter agrees to pay a cleaning fee for any soiled equipment.
6. Renter agrees to inform the Rental Station of any changes to the information provided, such as change of address or credit card account information used to secure this contract.
7. All rental rates and kit purchases are subject to applicable sales or use tax.
8. Renter will not move the equipment out of this State without the consent of the Rental Station.
9. Renter shall not allow the equipment to be used by any other person and shall accept FULL responsibility for the care, cleaning and return of the equipment in good working order.
10. Medela, Hollister and the Rental Station assume no responsibility for any damages to the renter or the equipment if renter uses kits not designated for the proper equipment. Rental Station warrants to repair or replace any equipment which is or becomes defective under normal use. Rental Station, Medela and Hollister will not be liable for incidental, consequential or any other damages resulting from defective equipment: their liability is limited to repair or replacement of the equipment. This warranty is given in lieu of all other warranties expressed or implied.
11. This agreement shall automatically terminate upon written or oral notice by the Renter or the Rental Station. Upon such notice, the renter shall have two (2) business days in which to return the equipment to the Rental Station and pay account in full.
12. Renter agrees to pay all fees including collection and court costs if contract is not fulfilled and/or renter fails to return the equipment and/or pay contract in full. Renter agrees to allow Rental Station, Medela or Hollister or any agency involved in collection of overdue amounts and/or equipment to obtain a credit report on Renter.
13. If Renter fails to return pump, Rental Station will charge Renter's credit card on file for the current suggested retail price for the equipment rented.

This Agreement shall be construed under the laws of the State where the Rental Station is located.
